## Quarterly Reporting Update: January 10, 2022

## **Total Award**

1. Savannah State's total allocation of CARES I and HEERF II, HEERF III for students totaled \$15,168,352, of the amount awarded, \$13,873,524 has been disbursed to students.

At the time of reporting Savannah State had 2,654 Title IV eligible students that received the Cares I and HEERF II, and HEERF III funds.

2. Savannah State's total allocation of CARES HBCU totaled \$8,997,951. Of the amount awarded, \$7,860,355 has been expended. Of the expended amount, \$6,938,861 was used to reimburse the institution for the remaining loss due to spring tuition, housing, dinning and student fee refunds and \$524,165 was used to fund the COVID Office established to manage COVID related activities at the University, and \$397,329 for student balance forgiveness.

The University's allocation of CARES I institutional spending was \$3,187,466. The total amount was used as reimbursement for tuition, housing, room and board, or other fee refunds.

- 3. Savannah State's allocation of HEERF II for institutional spending was \$20,336,156. Of the amount awarded, \$404,176 was used to support the one-time supplement for employees making less than \$80,000 per year, \$100,389 for COVID Office support, \$2,344,386 for laptops and other IT related items, COVID office supplies, and \$1,500,000 used to reimburse the University for state appropriation lost due to the decline in enrollment.
- 4. Savannah State's total allocation of HEERF III for institutional spending totaled \$8,954,041. The allocation has not been spent, however, the University is currently developing a spending plan that will be used to spend down the funds.
